**Instructions:** Mail entry form together with fee & copy of scorebook to: Ron Harris, PO Box 446, Palmyra, VA 22963. Dog may not start unless Trial Secretary has the scorebook. It is handler's responsibility to insure that tattoo/microchip is readable.

**Practice on Field:** January 21-22, 2015. RSPC training director will determine schedule. Other times may be arranged at the discretion of the training director.

**Event Schedule:** Schedule will be determined by the chairman. The schedule will be influenced by the number of entries and the weather. Check with the trial chairman. At the sole discretion of the trial chairman, time and weather conditions permitting, we will offer FH1, FH2, IPO FH. Please contact the trial chairman directly if you are interested. Check the web site for the most current information.

**Spectators:** Club members will direct competitors and spectators to parking areas. No one will be allowed to drive down to the trial field while dogs are being judged. Spectators are welcome at all trial events, both canine and social. However, we ask that spectators not bring dogs. Only dogs entered in the trial are allowed in the areas adjacent to the trial and tracking fields. No one who does not have a dog entered in the trial will be permitted to bring a dog onto the field. No exceptions.

**Please Note:** All dogs must be crated inside vehicles or under the direct control of the handler.

"Potty" your dogs only in designated areas or in the woods.

**Directions to Trial:** Newstead Farm is located at 1522 Oak Hill Lane, Palmyra, VA 22963, about 15 miles east of Charlottesville.

I 64, exit #136

Hwy 15 South about 8 miles into Palmyra

Left onto Courthouse Road (Rt 601) at BB & T Bank

Go about 1.5 miles, right onto Oak Hill Lane

Pass sign "end State maintenance", over bump

Follow signs to Canine Training Center, staying on paved driveway until it ends.
